#### Piers Island Improvement District

#### Bylaw # 109

A bylaw to establish officer positions and to establish the powers, duties and responsibilities of such officers and to repeal Bylaw No. 77, being the "Officer Appointment Bylaw".

The trustees of the Piers Island Improvement District ENACT as follows:

#### OFFICER POSITION

- 1. That Bylaw No. 77 of the Piers Island Improvement District, passed by the Trustees on the 15<sup>th</sup> of May 2001 and registered by the Inspector of Municipalities on the 15<sup>th</sup> day of June, 2001, is hereby repealed.
- 2. The following positions are established as officer positions:
  - (a) Officer responsible for corporate administration under section 738.2 of the Local Government Act whose title will be Corporate Secretary.
  - (b) Officer responsible for financial administration under section 738.3 of the Local Government Act whose title will be Financial Administrator.

#### POWERS, DUTIES AND RESPONSIBILITIES

- 3. The Corporate Secretary is assigned responsibility for corporate administration of the improvement district under section 738.2 of the Local Government Act.
- 4. The Financial Administrator is assigned responsibility for financial administration of the improvement district under section 738.3 of the Local Government Act.
- 5. In addition to the powers, duties and functions assigned to an officer in Section 3 and Section 4:
  - (a) The powers, duties and functions set out in Schedule "A" are assigned to the Corporate Secretary;
  - (b) The powers, duties and functions set out in Schedule "B" are assigned to the Financial Administrator;
